**WHEREAS**, by Commissioner Court Order, Applicants approved for the road use festival/civic event shall indemnify and hold Lee County harmless from any damages or injuries caused by use of the County Road(s) for the said festival or civic event; and,

**WHEREAS**, Lee County by approving the festival/civic event county road use, requires the said Applicant to provide Lee County the indemnity assurance as set forth herein below;

**NOW, THEREFORE**, in consideration of the premises herein and the mutual benefit of the parties hereto, it is mutually agreed that Applicant for its organization, members, and participants does hereby agree to indemnify fully and to save and hold harmless Lee County, its insurers, officials, agents or employees, from and against any and all liability, suits, actions, claims, costs and expenses (including reasonable attorney's fees) and damages of whatsoever nature arising, now or in the future, out of the festival/civic event conducted on Lee County road(s).
