

How Do You Get a Ballot by Mail?

The first step is to fill out an Application for Ballot by Mail (ABBM). You can find and print the application at VoteTexas.gov or request one from your county's election office. To apply for a ballot by mail, you must provide either: (1) your Texas Driver License, Personal ID or Election Identification Certificate Number; OR (2) the last 4 digits of your Social Security number. The number you provide must be associated with your voter registration record for your ABBM to be accepted.

When you're ready to mail your ballot, make sure you have completely filled out your carrier envelope before sealing and signing it. Underneath the privacy flap, which allows for the security of your personal information, you must provide either: (1) your Texas Driver License, Personal ID or Election Identification Certificate Number; OR (2) the last 4 digits of your Social Security number. You are welcome to provide both numbers.
