



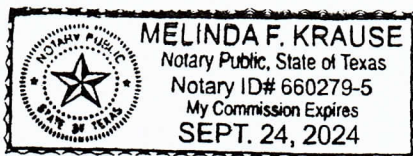

ORDER ADOPTING TAX RATE FOR MAINTENANCE AND OPERATIONS


On this the 28th day of September 2020, came to be considered the Tax Rate for Fiscal Year 2020-2021, and it appearing to the Commissioners' Court that said Tax Rate has been duly calculated in accordance with law by the Lee County Tax Office, and all required public notices fully filed, that the said Tax Rate for General Fund and Road and Bridge be and it is hereby, approved and adopted as follows:

The General Ad Valorem rate shall be \$0.4047 per one hundred dollar valuation.

The Lateral Road rate shall be \$0.1408 per one hundred dollar valuation.






**ORDER ADOPTING TAX RATE FOR


