## ORDER ADOPTING TAX RATE FOR MAINTENANCE AND OPERATIONS

On this the 23<sup>rd</sup> day of September 2024, came to be considered the 2024 Tax Rate for Fiscal Year 2024-2025, and it appearing to the Commissioners' Court that said Tax Rate has been duly calculated in accordance with law by the Lee County Tax Office, and all required public notices fully filed, that the said Tax Rate for General Fund and Road and Bridge be and it is hereby, approved and adopted as follows:

The General Ad Valorem rate shall be \$0.4102 per one hundred dollar valuation.

The Lateral Road rate shall be \$0.1084 per one hundred dollar valuation.

**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**




