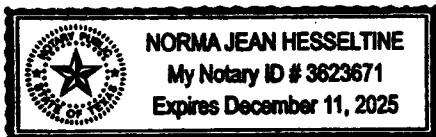

COMMENCING at a 1/2 inch iron rod found near a 5/8 inch iron rod at the West corner of a 2 acre tract conveyed to Bennie and Evelyn Mikulim described in instrument in Volume 641, Page 44 of the Deed Records of Lee County, the South corner of a certain 35.623 acre tract described in instrument in Volume 222, Pages 408 thru 410 of the Real Property Records of Lee County in the Northeast right-of-way line of State FM Hwy. No. 141 (80 ft. right-of-way);

THENCE South 44 degrees 34 minutes 48 seconds East with the Northeast right-of-way line of said highway a distance of 165.00 ft. to a 1/2 inch iron rod found marking the South corner of said 2 acre tract, the West corner and PLACE OF BEGINNING of the herein described 5.000 acre tract marking the West corner of said 82.53 acre tract described in Volume 1046, Page 416 of the Real Property Records of Lee County;
