Road and Bridge Precinct #4 is requesting bids for a bulldozer.

BIDS MUST BE RECEIVED AT THE LEE COUNTY CLERK'S OFFICE BEFORE 4:00 P.M., FRIDAY, MAY 5, 2023. BIDS WILL BE PUBLICLY OPENED AT 10:00 A.M. ON MAY 8, 2023 AND THE BID WILL BE AWARDED ON MAY 22, 2023 AT 10:00 A.M.

Lee County will not award any bid until the County Commissioner has inspected the bulldozer and determined that it has met the bid specifications.

Lee County reserves the right to accept or reject any or all bids or to accept the bid deemed most advantageous to Lee County. Lee County does not discriminate on the basis of race, color, national origin, sex, religion, age, or disability status in employment or provisions of service.

Certificate of Interested Parties-Form 1295

Section 2252.908 was added to the Government Code by the 84th Texas Legislature through adoption of House Bill 1295.

Senate Bill 255 adopted by the 85th Legislature Regular Session amended the law effective for contracts entered into or amended on or after January 1, 2018. Additional exemptions from Form 1295 requirement were added for 1) a contract with a publicly traded business entity, including a wholly owned subsidiary of the business entity, 2) a contract with an electric utility as defined by Section 31.002 of the Utilities Code, or 3) a contract with a gas utility as defined by Section 121.001 of the Utilities Code. Notarization of Form 1295 has been replaced by an unsworn statement under penalty of perjury by an authorized representative of the business entity.

The Texas Ethics Commission promulgated rules to implement the law and established an online portal for Form 1295: <https://www.ethics.state.tx.us/filinginfo/QuickFileAReport.php>

The law states that a County may not enter into a contract with a business entity unless a Certificate of Interested Parties (Form 1295) has been completed and provided to the County at the time the contract is considered for action by Commissioners' Court.

Lee County Commissioners' Court will not consider for action any bid, proposal and/or contract with a business entity unless it is accompanied by a completed, signed Form 1295 a certificate number from the Texas Ethics Commission or a signed statement declaring the provision of the law under which the business entity is exempt.

Bid must be submitted on the attached "Bid Form". In addition to the attached bid form, please attached the following a completed Form W-9 and Form 1295. Envelopes should be sealed and marked "**BID FOR A BULLDOZER**". Faxed bids will not be accepted. Lee County reserves the right to reject any or all bids.
